The Enrichment Centers, Inc. Policies

1. By registering your child(ren), you are hereby giving permission for your child to participate in our program, and shall release, hold harmless and indemnify us, and our affiliates, from any liability that could result from your child's participation in our program. All children enrolled in our programs must be insured under their personal or family medical insurance plans. By signing this you certify that you have adequate insurance to cover any injury or damage your child may suffer or cause, or alternatively, agree to assume medical liability for medical expenses incurred from such injury or damage. The Enrichment Centers, Inc. does not assume liability for any sickness or accidents occurring to program participants while in our programs. In case of an emergency and in the judgment of The Enrichment Centers' Program Staff, by signing this you give consent to emergency medical treatment for your child.

2. You are encouraged to come to the site to administer any necessary medication to your child as we cannot administer medication of any kind. Please apply sunscreen to your child when needed, or include a bottle labeled with child's name for self-application in his/her backpack. Please have your child dressed appropriately with closed toed footwear for any outdoor play.

3. Please provide your child with a non-perishable bag lunch and drink in a non-breakable container, as we are not able to provide food due to any potential allergies a child may have. If your child is in extended care, please also provide them with a snack. In the event that a staff member must provide your child with a lunch, a \$10 fee will be assessed. The Enrichment Centers, Inc. is not responsible for any possible illness caused from the food provided.

4. It is understood that all tuition is due at enrollment, after which no refund will be given for reason of withdrawal, suspension, or absence from our program. However, a credit may be applied toward any year-round or summer program. We reserve the option of requiring the withdrawal of any child whose inappropriate behavior prevents our program from proceeding constructively despite the efforts of staff and parents. Failure to disclose critical information about your child may result in dismissal from our program. In the rare instance that a child is asked to withdraw from a program for any reason, we cannot give refunds.

5. Please note that we are not responsible for children prior to or after their registered program time. An Overtime Fee may be applied to any child dropped off or picked up beyond agreed program hours. An Overtime Fee of \$5 for each 15 minutes, or portion of 15 minutes, per child may be assessed, with the first 15 minutes being a grace period. Payment for any Overtime Fee should be made to The Enrichment Centers at the time of the child's pick-up. We have the option, should it become necessary from repeated failure to secure payment on a timely basis, to request termination of a child from our program.
